If this is the case, then this problem could be solved easily by rewording this section of the British rules to take into account the laws of the country hosting the Championships.

We, in Canada, also have some small suggested changes to the BFTA rules, but do not want to dismiss the whole idea of the BFTA rules, as they are best set of rules that exist in our opinion. Using them as a framework makes the most sense to CAFTA. We are working on our proposal for the small changes we would like to see.

Perhaps an amended rule for insurance could be formulated that would satisfy all involved. Since NZAFTA may have the greatest concern, they may be in the best position to create the wording that would allow them to host a World Championship.

I am very pleased that these concerns are being sent to all RGBs, so that everyone stays informed.

Hello all,

BDS proposed already about more than a year ago to take the BFTA Rules as a solid base for the WFTF Core Rules. Our German FT Rules are the BFTA Rules adapted to our national firearms law conditions and passed the Federal Administration Office without any change (a rare exception!). Where is the difficulty to sort out all GB-specific paragraphs or sentences to change them into core rules which give objectively a solid and fair shooting standard for the Worlds which can be accepted by any NGB and which is then supported by the specific national rules of the host country??? BDS is convinced that we need much more comprehensive core rules than the present ones and that those should be based on the BFTA Rules which are -in our opinion- the best ones at all.

Just so we are not under any misunderstanding, NZAFTA has voted at its recent AGM to adopt WFTF CORE RULES as a class for competition within NZ. Whatever those rules ultimately become automatically applies to that class of competition. That is for that class alone, and we have two other

classes to cater for the vast majority of shooters who wish to pursue the traditional style of NZ Field Target as shot here for 20 years plus prior to joining WFTF.

We are not opposed to BFTA rules, as we use them also as a benchmark, but would like to see; as suggested, input from each RGB to modify them into a World Core Rules set, not just adopting the BFTA rules as is.

Insurance aside, there are only minor differences between what we do and what BFTA do.

It would still be important to allow additional classes to be run at the event such as a High Power class where the laws allow. This would be an inclusive and forward looking step, rather than an introverted and exclusive step to take. If FT is to grow, it cannot tie the sport down to an irrelevant legal requirement based upon a power limit from one part of the World. Would be interested in the thoughts of USA, as a founding member of WFTF.

Perhaps I am wrong, but I do not recall anyone suggesting that we adopt the BFTA rules as is. However, other than a few items that need to be worded properly in order to fall in line with each countries laws, these rules are proven and work well. In Canada we have a high power division, up to 20 ft/lb, with almost unlimited hold improvements, similar to the US rules. We also have a WFTF Division that follows the current WFTF Core Rules. We would not be opposed to a sub-class at the World Match, with separate awards provided by the host nation, using high power or what ever set of rules commonly used by that nation, in order to include individuals who choose to shoot in this class. We would prefer that the World Champion/s be declared using one set of rules and one power level so that all competing are doing so on a level playing field.

The WFTF Division or class is gaining popularity in Canada and the US. Many like the challenge of this style of shooting.
